

Senses of Cinema

Dear Author,

Thank you for submitting your article ("the Article") for review and considerations for publication in the online journal Senses of Cinema ("*Senses of Cinema*") published by Senses of Cinema Inc. ("the Publisher").

By submitting the Article for consideration for publication in *Senses of Cinema* you agree to the following terms and conditions and to the *Senses of Cinema* guidelines for publication.

Terms and Conditions of the Publisher

1. In considerations of *Senses of Cinema* publishing the Article in one edition ("the Edition") of *Senses of Cinema* you grant to the Publisher, its licensees, assignees and successors and their licensees, and any other person authorised by any of them, for the full term of the copyright in the Article, the non exclusive right and licence throughout the world ("the Territory") to use, reproduce, communicate to the public, publish, translate and otherwise exploit the Article, including abstracts and extracts of the Article, for any purpose, in all media whether now known or later devised, in perpetuity and licence others to do the same.
2. You agree not to license or deal with the Article for publication in any other online or print magazine, journal or website or in any form of media now known or later devised in the Territory prior to the publication of the Edition, provided that the Article is published by the Publisher within a reasonable time.
3. You may use the Article elsewhere after publication without prior permission from the Publisher provided that acknowledgment is given to *Senses of Cinema* as the original source of publication in the byline of any republication, and that it is notified so that our records show that the use is properly authorized.
4. You warrant that:
 - i. You are the owner of the copyright in the Article and you are entitled to grant the rights to the Article;
 - ii. the Article is original, except in respect of any extracts from other copyright material for which you have obtained permission for use;
 - iii. the article does not plagiarise another author's work and all material copied from existing sources has been correctly attributed;
 - iv. the contents of the Article, including but not limited to names, places, references and hyperlinks are accurate, true and correct;
 - v. the Article is not defamatory, does not infringe any copyright, moral right, right of privacy or confidentiality or any other right whatsoever of any person;
 - vi. you have obtained all written consents to reproduce or refer to any information from interviewees (if any), in a form satisfactory to the Publisher, and have disclosed to the

interviewee(s) the purpose of the interview and where and when the Article will be published;

- vii. that the Article has not been previously published and is not under consideration to be published by another journal, magazine.
5. The Writer agrees to indemnify the Publisher for any breaches of the warranties contained in this Agreement and for any liability that may arise from said breaches in the publication, reproduction or use of the Article.
6. The Publisher reserves the right to determine the date of publication of the Edition and the Edition in which the Article shall be published. The Publisher shall notify you of the date of publication. Should the Publisher fail to publish the Article within twelve months of receiving it from you, this Agreement shall cease to have effect.
7. The Publisher will use its best endeavours to attribute you as the author of the Article in all reproductions of the Article.
8. You consent to any and all acts or omissions of, or for the benefit of the Publisher, its licensees, assignees and successors and their licensees, and any other authorised person that may result in a failure to attribute you as the author of the Article, results in another person being attributed as the Author of the Article or to any alteration, amendment, deletion, modification or derogatory treatment of the Article that may otherwise constitute an infringement of your moral rights. To the extent permitted by law you agree not to sue, enforce a claim, bring any action or exercise any remedy in respect of any alleged breach or infringement of this clause.
9. You consent to the Publisher without limitation as to time, using and displaying your name, biography and approved likeness for the purpose of promoting and advertising the Article and the Edition.
10. You acknowledge and agree that the Publisher is entitled to fifty percent (50%) of any revenue and royalties as a result of the publication of the Article by the Publisher, its licensees, assignees and successors and their licensees, and any other authorised person, and that any payments received directly by the Publisher may be kept by the Publisher for its not-for-profit activities. It is your obligation to maintain correct and accurate records with the Publisher in order to facilitate payment. Should the Publisher be unable to contact you after a period of six (6) months after making reasonable enquiries to contact you, the Publisher is entitled to retain all of the revenues and royalties without any further obligation to you.
11. You agree to allow the Article to be made available as a downloadable PDF on the Australian Teachers of Media ("ATOM") Education Shop website, and for any resulting revenue to be treated in accordance with the conditions set out in Item 10 above, and disbursed to you once your share of accumulated proceeds reaches AU\$50. *If you specifically wish to opt out of this arrangement with ATOM, please inform us of this on submission of the Article.*
12. Nothing in this Agreement constitutes a relationship of employment, agency or partnership between the parties.
13. The Publisher may assign its rights under this Agreement.
14. This Agreement shall be construed in accordance with the Laws applicable in the State of Victoria, Australia, and each party submits to the jurisdiction of Victoria.
